ORDINANCE NO. 69

AN ORDINANCE OF THE CHARTER TOWNSHIP OF LANSING, INGHAM COUNTY, MICHIGAN, PROVIDING THAT THE CODE OF ORDINANCES BE AMENDED BY ADDING CHAPTER 109 ("DEMOLITION OF BUILDINGS AND STRUCTURES") TO TITLE X ("BUILDING REGULATIONS"); TO DEFINE CERTAIN WORDS AND TERMS; TO INDICATE THE PURPOSES FOR THE TOWNSHIP'S DEMOLITION ORDINANCE AND THE REQUIREMENT FOR OBTAINING PERMITS FOR DEMOLITION ACTIVITIES; TO INDICATE THE SCOPE OF THE TOWNSHIP'S DEMOLITION ORDINANCE; TO DESCRIBE THE PROCEDURES ESTABLISHED FOR THE ISSUANCE OF DEMOLITION PERMITS, INCLUDING THE PROCEDURE FOR REVIEW BY THE TOWNSHIP, THE DOCUMENTATION REQUIRED TO BE FILED BY THE APPLICANT, AND THE FEES RELATED THERETO; TO IDENTIFY THE STANDARDS FOR APPROVAL OF A DEMOLITION PERMIT AND DEMOLITION PLAN BY THE TOWNSHIP; TO IDENTIFY THE REQUIREMENTS FOR THE ISSUANCE OF DEMOLITION PERMITS; TO IDENTIFY DEPOSIT, INSURANCE, AND BOND REQUIREMENTS **RELATED** TO **DEMOLITION** PROJECTS; TO **IDENTIFY** REQUIREMENTS AND PROCEDURES RELATED TO DEMOLITION ACTIVITIES; TO PROVIDE THE TOWNSHIP WITH THE RIGHT TO ENFORCE ITS ORDINANCE AND THE TERMS OF DEMOLITION PERMITS AND APPROVAL DEMOLITION PLANS; TO PROVIDE THE TOWNSHIP WITH THE RIGHT TO COMPLETE DEMOLITION WORK; TO PROVIDE FOR PENALTIES WITH RESPECT TO VIOLATIONS OF **THIS** CHAPTER, **DEMOLITION PERMITS AND APPROVED** DEMOLITION PLANS; AND TO REPEAL IN ITS ENTIRETY CHAPTER 101 ("UNIFORM BUILDING CODE") OF TITLE X ("BUILDING REGULATIONS").
