**TAKE NOTICE THAT**, on Tuesday, June 17, 2014, the Township Board of the Charter Township of Lansing (the "Township") introduced two proposed ordinances, which proposed ordinances are generally described as follows:

ORDINANCE NO. 74

AN ORDINANCE OF THE CHARTER TOWNSHIP OF LANSING, INGHAM COUNTY, MICHIGAN, PROVIDING THAT THE CODE OF ORDINANCES, CHARTER TOWNSHIP OF LANSING, MICHIGAN, BE AMENDED BY ADDING CHAPTER 69A ("REGISTRATION AND INSPECTION OF RESIDENTIAL RENTAL PROPERTY") OF TITLE VI ("LICENSING") TO: REQUIRE AND PROVIDE FOR THE REGISTRATION AND INSPECTION OF RESIDENTIAL RENTAL PROPERTY AND DWELLING UNITS; AUTHORIZE CERTAIN TOWNSHIP OFFICIALS TO ENFORCE THE ORDINANCE; DESIGNATE VIOLATIONS OF THE ORDINANCE AS MUNICIPAL CIVIL INFRACTIONS; REPEAL ORDINANCES AND PORTIONS OF ORDINANCES INCONSISTENT WITH THIS ORDINANCE; AND PROVIDE AN EFFECTIVE DATE THEREOF

ORDINANCE NO. 73

AN ORDINANCE OF THE CHARTER TOWNSHIP OF LANSING, INGHAM COUNTY, MICHIGAN, PROVIDING THAT THE CODE OF ORDINANCES, CHARTER TOWNSHIP OF LANSING, MICHIGAN, BE AMENDED BY ADDING CHAPTER 101A ("PROPERTY MAINTENANCE CODE") OF TITLE X ("BUILDING REGULATIONS") TO: ADOPT, BY REFERENCE, THE INTERNATIONAL PROPERTY MAINTENANCE CODE; MAKE CERTAIN AMENDMENTS TO THE INTERNATIONAL PROPERTY MAINTENANCE CODE, AS ADOPTED; AUTHORIZE CERTAIN TOWNSHIP OFFICIALS TO ENFORCE THE ORDINANCE; DESIGNATE VIOLATIONS OF THE ORDINANCE AS MUNICIPAL CIVIL INFRACTIONS; REPEAL ORDINANCES AND PORTIONS OF ORDINANCES INCONSISTENT WITH THIS ORDINANCE; AND PROVIDE AN EFFECTIVE DATE THEREOF.
